This information is not published online. We may also ask additional questions through SurveyMonkey post events, should you wish to feedback.

Your personal data will be held in a CRM system (Mailchimp, Eventbrite, Survey Monkey) as well as the Arts Council of Wales' system

## How will your information be used?

Your contact details may be used to email a newsletter detailing news and events related to Arts Infopoint UK activity and wider artist mobility. Information supplied through SurveyMonkey and other feedback requests will be used to evaluate and report on both the Arts Infopoint UK activity and identify the issues and challenges facing artists when working internationally.
